EXTENSION OF RESERVATIONS AND RESTRICTIONS  
OF  
CAROLINA LAKES SUBDIVISION, PHASE III

WHEREAS, the existing Reservations and Restrictions were recorded in the Harnett County Court House, Book 731, Pages 541-546 on March 10, 1982.

WHEREAS, Article 15 allows for change in said covenants in whole or part by vote of the majority of the owners of the residential building sites by these or substantially identical covenants.

WHEREAS, the property owners of record were sent a notice by mail on February 1, 2008 advising them of a membership meeting on March 16, 2008 at 3 p.m. at the Carolina Lakes Clubhouse for the purpose of changing the reservations and restrictions of Phase III.

WHEREAS, an affirmative vote of 50% of votes cast by the owners of record was received,

WHEREAS, the first paragraph of Article 15 was deleted in its entirety and replaced with a new Article 15 which reads as follows.

TERM: These covenants are to run with the land and shall be binding on all parties and all persons claiming under them until December 1, 2010, at which time said covenants shall be automatically extended for successive periods of ten (10) years unless by vote of a majority of the then owners of the residential building sites covered by these or substantially identical covenants, it is agreed to change said covenants in whole or in part.

WHEREAS, this change does not alter any of the other existing reservations and restrictions for Phase III as recorded in Book 731, Pages 541-546.

NOW, THEREFORE, the above new Article 15 will become a part of the reservation and restrictions of Phase III and is effective the date of this filing.

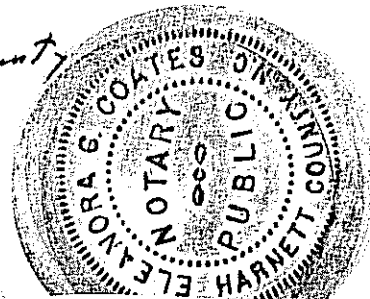
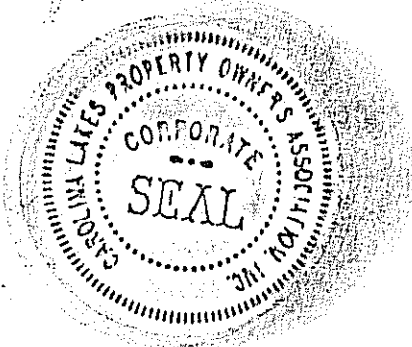
