(GREENMOOR – Phases 2G & 2I)

This FIFTH SUPPLEMENTAL DECLARATION TO THE DECLARATION OF COVENANTS, CONDITIONS, RESTRICTIONS AND EASEMENTS FOR GREENMOOR (this “**Supplement**”) is made as of the 31 day of July, 2018, by PULTE HOME COMPANY, LLC, a Michigan limited liability company (“**Declarant**”).

WHEREAS, Declarant executed, delivered and recorded that certain Declaration of Covenants, Conditions and Restrictions for Greenmoor dated as of the 14th day of February, 2017, and recorded in Book 16694, Pages 2207-2248 in the Register of Deeds Office of Wake County, as amended by that certain Supplemental Declaration to Declaration of Covenants, Conditions, Restrictions and Easements for Greenmoor, recorded in Book 16965, Pages 484-486 in the Register of Deed Office of Wake County, that certain Second Supplemental Declaration to Declaration of Covenants, Conditions and Restrictions and Easements for Greenmoor, recorded in Book 17052, Pages 1228-1230 in the Register of Deed Office of Wake County, that Third Supplemental Declaration to Declaration of Covenants, Conditions, Restrictions and Easements for Greenmoor, recorded in Book 17100, Pages 1801-1803 in the Register of Deed Office of Wake County, and that Fourth Supplemental Declaration to Declaration of Covenants, Conditions, Restrictions and Easements for Greenmoor, recorded in Book 17144, Pages 1359-1361 in the Register of Deed Office of Wake County (as amended and supplemented, the “**Declaration**”);

WHEREAS, since the recording of the Declaration, Declarant has acquired other certain real property, being part of the tract defined as “Additional Property” in the Declaration, which it desires to subject to the terms of the Declaration;

WHEREAS, pursuant to the terms of Section 2 of Article II of the Declaration, Declarant has the authority to add additional property to the Properties subject thereto pursuant to the terms of a "Supplemental Declaration" (as defined in the Declaration);

NOW, THEREFORE, Declarant, in consideration of the foregoing recitals, which are incorporated herein by this reference, does hereby declare as follows:

1. Recitals; Definitions. The above recitals and the definitions set forth therein are true and correct and are hereby incorporated into this Supplement as if set forth at length herein. Any capitalized terms not otherwise defined herein shall have the meanings assigned thereto in the Declaration.

2. Annexation of Additional Property. All of that certain real property described on Exhibit "A" attached hereto and incorporated herein by this reference is hereby annexed and subjected to the terms of the Declaration.

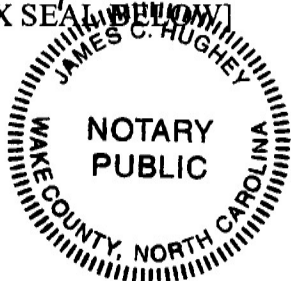
